This End-User Digital Music License Agreement (the "Agreement") is a legally binding contract entered into by and between Sonabite ("Licensors") and the individual user or downloader accessing audio assets via the Sonabite interface under the Free/Personal Tier designation ("Licensee"). Downloading any audio files, compositions, tracks, or sound effects (collectively, the "Audio Content") from Sonabite constitutes complete, irrevocable acceptance of all terms outlined herein.

1. GRANT OF LICENSE

Subject to complete adherence to the restrictions in Section 2, Licensors grants Licensee a non-exclusive, non-transferable, non-sublicensable, worldwide, royalty-free, perpetual license to synchronize the Audio Content into specialized personal, non-commercial media assemblies ("End Works").

2. PERMITTED USES (WHAT YOU CAN DO)

Licensee is legally authorized to utilize the Audio Content solely within the following environments:

- **Hobbyist & Personal Projects:** Private video edits, family home recordings, personal software projects, and creative exercises not tied to businesses, revenue streams, or organizational brands.
- **Non-Monetized Social Media Content:** Individual posts on platforms including YouTube, Instagram, TikTok, and Facebook, provided that the underlying profile or specific content piece remains completely un-monetized, free of active digital advertisement roll-overs, and clear of corporate sponsorship placement.
- **Academic & Student Evaluations:** Classroom assignments, student film entries, film school portfolios, and academic visual presentations executed within a certified learning institution framework.

CRITICAL EXCLUSION: This license covers only **one (1) single standalone project execution per asset assignment**. Broad systemic distribution across variable independent web platforms or collaborative portfolios requires a Tier status upgrade to Commercial or Broadcast frameworks.

3. EXPLICIT PROHIBITIONS (WHAT YOU CANNOT DO)

Any violation of the following prohibitions represents an instantaneous, auto-terminating material breach of this Agreement, exposing the operator to direct copyright infringement enforcement actions:

1. **Commercial Monetization:** Licensee SHALL NOT turn on monetization settings, collect ad revenue sharing splits, integrate corporate sponsor integrations, or use assets inside any project directly or indirectly linked to an invoice, business promotion, or corporate entity.
2. **No Standalone Audio Re-distribution:** Audio Content must be completely sub-mixed into a final visual video or software media layout. Selling, looping, converting, sample-slicing, or hosting raw tracking stems as standalone files, production library items, or audio-only streams on external services (Spotify, Apple Music, SoundCloud) is strictly forbidden.
3. **No Content ID / Performance Rights Registration:** Licensee is permanently blocked from uploading audio or sub-mixed visual derivatives containing Sonabite material to automated Copyright Enforcement Nodes (e.g., YouTube Content ID, Facebook Rights Manager) or claiming copyright ownership with global performance rights organizations.

4. INDEMNIFICATION & LIABILITY THRESHOLDS

The Audio Content is provided "as is" without warranty of any kind. Licensor provides no warranty that assets are clear against claims filed by unauthorized secondary distributors or modified metadata wrappers. Licensor's aggregate legal liability for any asset dispute shall be explicitly capped at \$0.00 USD under this free tier framework.
